Subject: Austerity Measures - Out Sourcing Contract Labour.

During the various review meetings in the CO BSNL with the higher management, the liquidity position & financial crunch in BSNL had been discussed & it was decided to issue necessary instructions/guidelines immediately to reduce the expenditure in the various items including Out Sourcing Contract Labour.

Hence, suitable measures may be taken to reduce expenditure on outsourcing in the administrative/operational activities in field i.e. housekeeping, Security & data feeding etc. Thus a thorough review of all outsourcing contracts involving labour should be done with a view to reduce expenditure and obtain savings. Next quarter payments may be released only after it is certified by CGM/ IFA that such a review has been done. The action may be taken in cases where revenue generation is minimal/less as compared to expenditure incurred on the same, other than the salary expenditure.

In view of above, a thorough review of all outsources contracts involving manpower should be done by all CGMs/IFAs. Performance/status report may be submitted by 20th June, 2019

In addition to above, it has been directed that analysis may also clearly point out the exchanges which are critical for network and /or have potential for revenue increase to offset the losses due to high expenditure on such exchanges.

Subject: Austerity Measures - review of AMC charges

During the various review meetings in the CO BSNL with the higher management, the liquidity position & financial crunch in BSNL had been discussed & it was decided to issue necessary instructions/guidelines immediately to reduce the expenditure in the various items including review of AMC charges in BSNL.

Expenditure under control of CGM/SSA Heads in respect of all Telecom equipment and exchanges should be reviewed and may be revised according to working connections/revenue generation/life of equipment etc, so that there is a reduction in AMC expenditure. O&M and AMC contracts may be reviewed by CGM/SSA Heads and only essential contracts are continued.

Further, a review of AMC expenditure be done by nodal sections in corporate office with concurrences of PF section. Similarly review of AMC may be done by CGMs/SSA heads in field units with concurrence of their respective IFAs, with an objective to reduce such expenditure and obtain savings. Release of payments for next quarter may be done only after such a review is certified to have been completed by nodal sections in corporate office and CGM/ IFA in the field units.
