**Subject: Promotion of AOs/Sr.AOs to the grade of STS on ad-hoc basis - reg.**

There is a proposal to conduct CPC for promotion to the grade of STS in Telecom Finance on adhoc basis in respect of eligible AOs/Sr. AOs as per BSNL MS Recruitment Rules, which is presently under consideration of Management Committee of BSNL Board. A list showing the AOs/Sr.AOs posted in various Circles, who are eligible for promotion by the CPC is given in 'Annexure - 'A' and 'B'.

2. As the CPC is to be conducted in a time bound manner, Circle IFAs are requested to kindly arrange to send the CRs for the year 2010-11 and any other CRs for the period from 1.4.2006 to 31.3.2011 lying in their office, in respect of the officers whose names are included in the enclosed list, which was not sent earlier to CS to Director (Finance), CO BSNL.

3. There may be cases of some AOs/Sr. AOs, whose circle of posting shown in the list may not be correct. In such cases, ACRs/APARs ibid, in respect of those officers, who are working in your circle, but their present circle of posting has been shown otherwise, in the above mentioned list, may also be sent to CS to Director (Finance), CO BSNL, under intimation to this office.

4. The points that need attention are:

a) In case, the official against whose names the word "OC","SC" or "ST" have been wrongly indicated and required to be modified, the factual position may be verified from the service records of the official and confirmed

b) It may be checked and verified, whether the name of the officers, who have already been promoted to the higher grade / who have retired / voluntarily retired / expired / whose promotion has been withheld at the circle level / not permanently absorbed in BSNL / not in service or any other reasons are included in this eligibility list. In such cases, their names may be brought to the notice of this office.

c) Name of any officer belonging to Telecom Finance, who is eligible for promotion to the grade of STS as per BSNL MS RR but not included in the above list may also be checked up and intimated along with reasons therefore.


d) In case, APAR grading during the period from 1.4.2006 to 31.3.2011 in respect of the officers included in the lists are found below the prescribed bench mark given in BSNLMS Recruitment Rules in case of promotion to the grade of STS on ad-hoc basis in Telecom Finance, concerned circles are requested to ensure that DOP&T guidelines contained in letter No 21011/1/2010-Estt A dated 13<sup>th</sup> April, 2010 on the subject, has been adhered to in such cases.
