## **ORDER**

Subject: Regularisation of STS Ad-hoc of Telecom Finance to the grade of STS (CAO) on regular basis – regarding.

Approval of the Competent Authority is hereby conveyed for regularization of the following executive of Telecom Finance in the grade of STS (Ad-hoc) to the grade of STS (CAO/AGM) on regular basis in the IDA pay scale of Rs 29,100-54,500, notionally with effect from the date, when his juniors have taken over the charge of the post of CAO on regular basis in their respective circle, as per this office order No. 2-1/2012 SEA BSNL dated 16-03-2015, 10-04-2015, 28-05-2015, 8<sup>th</sup> July 2015,10<sup>th</sup> July, 2015, 22<sup>nd</sup> July 2015, 26<sup>th</sup> October 2015 & 27<sup>th</sup> September 2016 and actually from the date of joining as CAO on regular basis. However, BSNL CO retains its powers to transfer him out of his circles/units, in the interest of Company.

- 2. The regularisation of the above executive is further subject to the condition that no disciplinary / vigilance case is pending against the executive. In case any disciplinary/ Vigilance case of the type referred to in D.O. P&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 is pending against the executive or some punishment like stoppage of increment etc. is current, he should not be promoted and the matter should be reported to SEA and Vigilance Branch of Corporate Office immediately.
- 3. Before implementation of this order, the Circle(s) must ensure that Presidential orders for absorption of the executive in BSNL has been issued and above executive is working in the grade of STS on ad-hoc basis in the circle. Any other discrepancy, viz name of the executive shown in the order varies may be brought to the notice of BSNL CO with supporting documents for rectification of records. Moreover, if the executive is not working in the respective circle shown against him, the orders should not be implemented, but the executive relieved immediately with direction to report to the circle of posting shown against him and the matter should be reported to CO BSNL
- 4. On regularisation, the pay will be fixed as contemplated in BSNL MS RR, communicated vide no 400-106/2007-Pers I dated 14.7.2009.
- 5. IFAs of the concerned Circles may check up the up-to-date position regarding the vacancies in the grade of STS in their circle after implementation of the above order and intimate the same to SEA Section, CO BSNL, New Delhi.

- 6. The seniority in the grade of STS (Regular) in Telecom Finance will be communicated subsequently.
- 7. Necessary charge report may be sent to all concerned including Dy Manager (SEA), CO BSNL.
