ORDER

- v. Due to any direction from Hon'ble Court/CAT for not effecting the promotion to an individual.

The case may be brought to the notice of this immediately for taking appropriate action.


3. The officer is required to join his promotion assignment within a time period of 40 [forty] days from the date of issue of this order. In case, the officer concerned failed to join his promotional assignment within the prescribed time period of 40 days, he should not be allowed to be relieved or join the post thereafter. In such an event, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action. Further, no request for the modification of promotion/posting orders shall be entertained after the expiry of the 40 [forty] days period.

4. On promotion, the pay will be fixed as contemplated in BSNL MSRR, communicated vide No.400-106/2007-Pers.I dated 14.07.2009.

5. After promotion to Deputy General Manager grade on regular basis, the seniority of the Executive in the grade of DGM in Telecom Finance will be fixed and communicated subsequently as per guideline issued from time to time.

6. Necessary charge report may be sent to all concerned including Dy. Manager (SEA), CO BSNL and entries be made in HRMS/ERP/Service book.
