**ORDER**

Subject: - Promotion/posting of directly recruited DR-DGM [1st batch] of Telecom Operation Stream to the grade of **General Manager** [Telecom] on regular basis w.r.t to their juniors.

Approval of the competent authority is hereby conveyed to promote **42 directly recruited DR-DGMs** of 1<sup>st</sup> batch [*as in Annexure*] of Telecom Operation Stream to the grade of **General Manager** [Telecom Stream] on regular basis in the IDA scale of pay of Rs. 62,000-80,000/- [**E-9**] under the provisions of BSNL MSRRs, notionally w.e.f. 11-04-2017 [*the date when their junior absorbed officers were promoted to GM grade w.e.f. 11-04-2017*] and actually from the date of assumption of the charge of the promoted post.

2. The promotion order will, however, not be effected by the concerned Circle/Unit in case:
  - Any disciplinary /vigilance case is pending or executive is under currency of any penalty or any other type of circumstances referred to in DoPT OM No. 22011/4/91-Estt. (A) dated 14.09.1992.
  - The Executive is on deputation to TCIL etc.
  - Any direction from Hon'ble Court/CAT for not effecting the promotion to an individual.

*Such cases may be brought to the notice of this office immediately for taking further appropriate action.*
3. Pay fixation applicable to the executive/s may be done in accordance with BSNL order No. 1-50/2008-PAT (BSNL) dated 05.03.2009 read with BSNL order No. 400-61/2004-Pers.I/308 dated 18.01.2007 and any subsequent related order/s issued in this regard from time to time.
4. The executive/s are required to join their promotion assignment immediately & within 40 days from the date of this order positively. If an executive fails to join the assigned posting on promotion within the prescribed period, the promotion order shall become inoperative and the executive/s shall not be allowed to join the promoted post, thereafter. In such circumstances, the matter may immediately be reported to this office.
5. The leave, if any, requested by any executive, who is under transfer, may not be granted. However, if any executive desires leave, he/she can apply for the same to the Competent Authority only after joining the assigned posting on promotion and the Competent Authority will sanction leave, if it is considered justified, in the normal course.
