Subject:- Representations of BSNL Executives against Seniority List in the grade of EE(C).

Sir.

I am directed to refer to your letter No. 10-19/2008-AD (BW-III) dated 4.3.2015 forwarding the representations of EEs(Civil) for advancement of their promotion to the grade of EE(Civil) are examined in this office with the following observations:-

(a) Representations had earlier been received from EEs(Civil) requesting for holding a review DPC taking into account all the vacancies that were available as on 30.3.2005. The case was examined in totality and the vacancy position in the grade of EE(C) falling in the share of AEE(C) was re-worked, on review of the vacancy position, it was found there were 64 vacancies available in the grade of EE(C) for the vacancy year 2004-05 and 9 vacancies were available for the vacancy year 2005-06. Hence, the assumption that the vacancy position has not been calculated properly is not correct.

(b) Accordingly a review DPC was held on 26.3.2008 for filling up the vacancies that were available as on for the vacancy year 2005-06 & 2006-07. In this review DPC, only those officers who were considered by the DPCs held in 2005 have been considered for promotion to the grade of EE(C). From the vacancy year 2005-06 only two officers were selected by the DPC. Assessment of officers of UR category not made as these officers were not considered in the earlier DPCs and were subsequently absorbed in MTNL/BSNL on the date of the review DPC i.e. 26.3.2008 and

the promotion of the absorbed employees to be made by PSUs

concerned as per their personnel policy.

(c) Representations were received stating that DOPT clarification dated 31.1.2005 needs to be considered as the promotion from AEE(C) to EE(C) is made on the basis of seniority cum fitness basis and not on "merit". The case was referred to DOP&T for advice as to whether for the review DPC held on 26.3.2008. DOP&T OM dated 31.1.2005 could be applicable or not. DOPT advised that action may be taken in the light of DOPT OM dated 11.7.2002 and 31.1.2005. Accordingly a review DPC was held on 12.03.2009 for the panel year 2004-05 & 2005-06. DOT order no. 3-1/2004-CWG dated 25.03.2009 was issued based on the recommendations of review DPC held on 12.3.2009.

Accordingly all the representations received in the subject are to be disposed of on the above lines by BSNL.
