
6. They will be on probation for a period of 2 years.

Sub.: Regarding conduct of "Training cum Examination" for Accounts & Law of Contract at ALTTC Ghaziabad for the Executives of Civil/Electrical Disciplines.

In supersession to the earlier instruction issued for conducting the departmental examination for Accounts for SDE(Civil/Elect)/ AEE(Civil/Elect) and departmental examination for Law of Contract for Executive Engineer(Civil/Elect), approval of the competent authority is hereby conveyed for :

- a) Discontinuation of holding of existing procedure of holding of Departmental Examination for Accounts for SDE(Civil/Electrical)/ AEE(Civil/Electrical) & Departmental Examination for Law of Contract for EE(Civil/ Electrical).
- b) Conducting "training cum examination" for Accounts for SDE(Civil/Electrical) /AEE(Civil/Electrical) & "training cum examination" for Law of Contract for EE(Civil/Electrical) at ALTTC Ghaziabad as per the Scheme and Syllabus enclosed herewith.

The training cum examination shall be of six days module comprising of two phases :

- i. Training for five days.
- ii. Conduction of the examination on sixth day.

(Note : After imparting training for five days, examination shall be conducted on sixth day by ALTTC in the similar way as is being done for Time bound/ Post based Executive promotion policy for Gr'B' level officers viz. E1-E2 ( JTO-SDE) to E4- E5 (DE- DGM) in accordance to corporate office instructions. Result to be declared and uploaded on CMTS package by ALTTC Ghaziabad).

The copy of recasted scheme and syllabus for SDE(Civil/Electrical) & EE(Civil/Electrical) is enclosed herewith for wide circulation among Executives.

The calendar of training cum examination will be notified by the ALTTC Ghaziabad.

The order is effective from the date of issue.
