In case, APARs of any Executive is not available in the circle, the following information may be furnished in respect of those Executives:-

- i) Whether these executives have submitted their self appraisal to the reporting officer.
- ii) The name of reporting and reviewing officer of this reporting period may be intimated along with status of these officers whether in service or retired.
- iii) Any action has been taken by Reporting officer in case self appraisal was not submitted by them, as per rule.
- iv) What is the status of the APAR by reporting officer and who is Reviewing officer, whether he is retired or in service.
