
**Subject: Deployment of Gr. B Officers to TERM Cells of DOT**

Subject-Posting of 'B' officers (Sr.SDE/SDE/JTO) on temporary basis in TERM Cells of DOT.

Sir,

I am directed to refer to the subject mentioned above and to say that due to acute shortage of TES Gr'B' officers in DoT and its attached offices, it has been decided by the competent authority to request BSNL to post seven (7) Group 'B' officers (Sr.SDE/SDE/JTO) of BSNL on purely temporary & stop-gap arrangement basis in each TERM Cell of DOT (34) located all over India, initially for a period of two years. Pay & allowances of the officers so deputed would be paid by BSNL and would be reimbursed by DOT on mutually agreed terms and condition between BSNL and DoT.

2. Accordingly, BSNL Circles may be asked to post, Group 'B' officers (Sr.SDE/SDE/JTO) who have minimum three years experience in one or more of the technologies like Broad Band, Leased Circuits, Mobile Services, Electronic Switching in the fields of planning/ installations/operations, directly to the TERM Cells of DOT in consultation with DDsG of the respective TERM Cells. A list of TERM Cells is enclosed.

3. Considering the urgency of the requirement of manpower in TERM Cells, the said exercise may be completed within 15 days.

4. This office letter of even no. dated 25.10.2010 may be treated as withdrawn.
