6. This issues with the approval of Competent Authority.



**ORDER**

Subject: Repatriation of ITS officers deployed in BSNL and MTNL.

Whereas the issues relating to absorption of Group 'A' officers including Indian Telecom Service (ITS) officers in Bharat Sanchar Nigam Limited (BSNL)/Mahanagar Telephone Nigam Limited (MTNL) were considered and decided by Hon'ble High Court of Delhi by its judgement/order dated 17.04.2012 in WP(C) No. 22515/2005 filed by Indian Telecom Service Association (ITSA) vs. UOI & others and connected writ petitions. Thereafter, in the context of Civil Misc. Petitions filed by BSNL and MTNL seeking extension of time for reverting Group 'A' officers who had not opted for absorption back to their parent Department, Hon'ble High Court finally directed vide its order dated 15.02.2013 that within six weeks from the date of this order, the mandamus issued by this Court as per the decision dated April 17, 2012 would be positively complied with.

2. Whereas the issues relating to absorption of Group 'A' officers including ITS officers in BSNL/MTNL and the exigent requirement of these officers in BSNL were considered and decided by the Union Cabinet in its meeting held on 13.2.2013. In pursuance of the Cabinet decision and in the context of the orders passed by Hon'ble High Court of Delhi in the aforementioned writ petitions, orders dated 11.03.2013 were issued by Department of Telecommunications for deployment of 988 ITS officers in BSNL and MTNL (911 in BSNL and 77 in MTNL) for a period of 10 years on year to year diminishing basis w.e.f. 11.03.2013 (AN) on the terms and conditions of deployment approved by the Cabinet.


3. Whereas a Contempt Petition No. 243/2013 in WP(C) No. 22515/2005 has been filed by ITSA before Hon'ble High Court of Delhi in which the petitioner has mainly charged that the orders dated 11.03.2013 issued by the Department of Telecommunications for deployment of ITS officers in BSNL and MTNL on year to year diminishing basis are in violation of the aforementioned judgement/order dated 17.04.2012 passed by Hon'ble High Court of Delhi.

4. Whereas, during the pendency of the aforesaid contempt petition, Department of Telecommunications reviewed its position with regard to the impugned order dated 11.03.2013 issued by this Department. Consequent to this review, a short affidavit has been filed by the Department of Telecommunications in the Hon'ble High Court of Delhi proposing, inter-alia, repatriation of ITS deployed in BSNL and MTNL back to this Department and fresh deployment of ITS officers in these organisations in batches of around 100.

Therefore, in terms of the aforementioned short affidavit filed by Department of Telecommunications in the Hon'ble High Court of Delhi, 100 ITS officers deployed in BSNL as per the list enclosed are hereby repatriated back to this Department. These officers are directed to report to the Principal Controller of Communication Accounts (Pr.
