Sub:- JAO's Induction Training Phase-II (5 Weeks) for Departmental candidates against 40% quota from 21<sup>st</sup> April 2008.

It has been decided to impart 5-Weeks Phase-II training w.e.f. 21<sup>st</sup> April 2008 to Departmental JAO Probationers (40% quota) who had completed their Phase I training. Six candidates of departmental 10% quota are also included for the above training as there is no prospective batch of Phase II training in near future. Accordingly a list of **79** JAO Probationers showing the circle where they are presently working and name of the training centre allotted to them is enclosed as Annexure. The list contains all the candidates who have completed their Phase I training during June 2007 & Nov. 2007.

2. The inter-se-seniority of Departmental JAO's is to be fixed based on the overall performance/marks obtained by the candidates in all the Three Phases of Induction Training. Accordingly Training Centres are requested to please send full details in respect of the performance/marks obtained by the candidates (lists for 40% and 10% quota candidates should be prepared separately as the seniority is to be maintained separately for them) to the CGM NATFM, Hyderabad for further necessary action/ consolidation.
3. Other Terms and Conditions issued by SEA Section from time to time may be followed.
4. Only those JAO Probationers who have completed their 4 weeks pre-appointment training and issued Appointment Orders by the Circle are to be sent for the above training. However, left-out cases of eligible JAOs if any, may be intimated to this office immediately.
5. All concerned are requested to relieve the officers in time to enable them to reach the Training Centre on the Scheduled date.
