Sub:- JAO's Induction Training Phase-III (5 Weeks) for Departmental candidates against 40% quota from 01^{st} September 2008.

It has been decided to impart 5-Weeks Phase-III training w.e.f. 01^{st} September 2008 to Departmental JAO Probationers (40% quota) who had completed their Phase II training. Accordingly a list of **164** JAO Probationers is enclosed as Annexure, showing the circle where they are presently working and name of the training centre allotted to candidates.

- 2. The inter-se-seniority of Departmental JAO's is to be fixed based on the overall performance/marks obtained by the candidates in all the Three Phases of Induction Training. Accordingly Training Centres are requested to please send full details in respect of the performance/marks obtained by the candidates to the CGM NATFM, Hyderabad for further necessary action/ consolidation.
- 3. Other Terms and Conditions issued by SEA Section from time to time may be followed. It may also be ensured that no vigilance / disciplinary case is pending or being contemplated against the candidates before relieving them for training. Such cases, if any, may be brought to the notice of this office for information.
- 4. Only those JAO Probationers who have completed their 5 weeks phase II training are to be sent for the above training. However, left-out cases of eligible JAOs of previous batches, if any, may be intimated to this office immediately.
- 5. All concerned are requested to relieve the officers in time to enable them to reach the Training Centre on the Scheduled date.
