- 2. The names of candidates who have secured the minimum qualifying marks of 50% in each Paper are given in **Annexure A** and those who are passed under the relaxed standards i.e. 45% in each Paper are given in **Annexure B (SC) Annexure C (ST)**. The marks secured by these successful candidates, category, year of eligibility have also been mentioned.
- 3. The examination was held for filling up vacancies pertaining to the four years i.e. 2006-07, 2007-08, 2008-09 & 2009-10 and backlog vacancies of 271 (SC-59 & ST-212) carried forwarded to 2006-07 and onwards.
