

This has reference to the letter by BSNL authorities to Delhi Unit and the subsequent communication by Northern Zonal office in the matter.

The Competent Authority has approved issuing of GI in lieu of GSLI for new employees of BSNL all over India with following guidelines:

1. The premium to be charged for the new GI in lieu of GSLI will be same as that of premium rate under their respective GSLI policies (risk Portion only) plus service tax extra. The Life cover too will be same as per their GSLI scheme, graded or uniform as the case may be.
2. As the policy can not be backdated beyond financial year, date of commencement under new policy will be date coinciding with ARD in current financial year.
3. A new GI policy can be taken for their every GSLI policy to provide cover to new employees appointed under their respective circles.

The Competent Authority has approved issuing of GI in lieu of GSLI for new employees of BSNL all over India with following guidelines:

1. As per provisions of P&GS circular no. 1338, the premium to be charged for the new GI in lieu of GSLI will be same as that of premium rate under their respective GSLI policies (risk Portion only) plus service tax extra. The Life cover too will be same as per their GSLI scheme, graded or uniform as the case may be.
2. As the policy can not be backdated beyond financial year, date of commencement under new policy will be date coinciding with ARD in current financial year.
3. A new GI policy can be taken for their every GSLI policy to provide cover to new employees appointed under their respective circle.
