

ORDER

On the basis of results declared vide Rectt. Branch letter No.58-1/2018-Rectt dated 08.03.2019 of Limited Internal Competitive Examination (LICE) held on 19.01.2019 for promotion of Steno Gr."D" to the grade of Personal Assistant in BSNL Corporate Office, approval of the competent authority is hereby conveyed for promotion of the following official to the grade of Personal Assistant in the IDA pay scale of Rs.16400-40500/- with effect from the date they assume charge of the post:

2. The officials shall however, be not promoted by the concerned circle/units in case:
 - a. Disciplinary/Vigilance case is pending and VC is withheld in terms of instructions contained in DOP&T OM No.22011/4/91-Estt.(A) dated 14.09.1992.
 - b. The official is under the currency of any penalty.
 - c. Presidential order for absorption in BSNL is not issued due to any reason.
 - d. Due to any direction from Hon'ble Court/CAT for not effecting the promotion to an individual.
 - e. The officer has resigned/taken VR/Retired/Expired on the date of issue of this order.
 - f. They have not fulfilled the prescribed eligibility as per the relevant RRs.
3. The promoted official is required to join her promotion assignment immediately before 40 days from the date of issue of this order positively.
4. In case the official concerned fail to join the promotional assignment within the prescribed period, he/she should not be relieved to join the post thereafter. In such situation, the promotion order shall become inoperative and such cases shall be reported to this office. Further, no request for modification of posting order shall accordingly be entertained.
5. The promoted officials will continue to remain posted at their present place of posting as shown in the table till further orders.
7. Necessary joining report may be furnished to this section through the concerned controlling officer.


