Branch as on 4-12-2014, 16 cases could be closed (13 out of 58 in the Circles and 3 out of 9 cases in BSNL CO, New Delhi) till now, and 10 cases registered a new, the final tally as on dated is 61 (55 cases with Circles and 6 cases with BSNL CO, New Delhi)
- 3. You may also refer the earlier correspondences from Rectt. Branch dated 4-12-2014 and 5-1-2015, wherein it was advised to submit reply affidavits/MAs alongwith earlier judgements received in favour of BSNL as the most of the cases are of similar nature/context where BSNL has already successfully contested and received verdicts in its favour from other Hon'ble CATs/PBCAT/HC/Supreme Court.
- However, it is observed and regretted to say that in most of the cases, reply 4. affidavits/misc. petitions are yet be filed. Delay in finalization of long pending cases not only results in heavy expenditure towards legal expenses, loss of invaluable time but also affects smooth functioning of the office machinery. It is, therefore, requested you to make all out efforts for early disposal of said pending court / CAT cases by filing reply affidavits/misc. petitions in your Circle by the end of March, 2015 under intimation to the Recruitment Branch.
- Detailed status of the cases as on 31-3-2015 may be sent to the Rectt. Branch, BSNL CO by 1<sup>st</sup> week of April 2015 positively for further review at this end.
