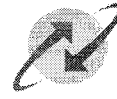

without prior permission of the BSNL CO. The officer can apply for leave to the competent authority at the new place of posting, who will sanction the same if it is justified in the normal course.


