- 2. The officers are required to join their promotional assignment within a period of 40 days from the date of issue of this order. The CGM concerned may please ensure that the promotion/posting order in respect of officer is issued in time to join his promotional assignment within the prescribed time limit of 40 days from the date of issue of this order.
