Sub:- <u>Inordinate delay in relieving of executives/officers under transfer to other</u> <u>Circles/Units - Relieving of such officers from BSNL CO itself - regarding.</u>

Transfer & posting are issued based on the requirement in a circle vis-a-vis the vacancy shortage in different grades & other administrative requirements. BSNL Corporate Office has issued many transfer orders which have not been implemented in the field and officers are not relieved from their present place of posting thereby creating a hindrance in the balanced availability of human resource. Instructions to relieve such officers are being issued from BSNL CO from time to time. Recently such instructions have been reiterated & issued vide letter(s) dated 30.06.2014, 28.11.2014 and 12.03.2015.

- 2. Accordingly, a list of DGMs (Finance)/CAOs who are yet to be relieved by the concerned circles/units against their pending orders has been prepared as per Annexure-`A' & `B' for information and appropriate disposal. Moreover, Name(s) of any other officer/officers whose orders are pending for implementation for considerable time but not included inadvertently may also be considered for relieving.
- 3. Retention or any other modification in the pending orders, if any, noticed in respect of any officer in the list may be communicated to this office by 28-12-2015 for making due corrections thereto. Further, name(s) of the officers already relieved or likely to be relieved on or before 30-12-2015 may also be intimated to this office.
- 4. In view of above, respective Heads of Circles/Units may cause releasing of the officers by 30-12-2015 positively, as the last chance; else BSNL CO will directly release these officers on 31-12-2015 itself.
- 5. Further, it has also been decided by the competent authority that henceforth BSNL CO will directly release such executives/officers whose transfer orders remains pending in excess of 3 months' time.

This issues with the approval of the competent authority.
