Subject:- Fixation of pay in the cadre of stenographers Grade-I on absorption in BSNL w.e.f. 1.10.2000.

Sir,

It has been brought to the notice of this office that the fixation of pay in the cadre of Stenographers Grade-I in CDA pay scale of Rs.5500-9000 has been done in the IDA pay scale of Rs.7830-230-12430 as on 1.10.2000, which is not in order.

2. The instructions vide BSNL letter No.BSNL/11/SR-2001 dated 14.1.2002 were reversed by order No.BSNL/4/SR/2001 dated 24.1.2002 and ordered that the option for Group 'C' employees treated as null and void may be revived and these officers may be considered to have opted for absorption w.e.f. 1.10.2000 as Group 'C' employees except in the case of Arch. Asstt. Gr.I. Accordingly, the absorption of Stenographers Grade-I on 1.10.2000 in the field units may be treated as Group 'C'.

3. The post of Stenographer Gr.I in the field units became "Executive" only w.e.f. 1.1.2004 and prior to that its status was that of non-executive. The pay of Stenographer Grade-I in the CDA pay scale of Rs.5500-175-9000, as on 1.10.2000, is first to be fixed in the IDA pay scale of Rs.7800-225-11175 [substantive of PS(adhoc)] and then in the IDA pay scale of Rs.9850-14600 of promoted post (PS (adhoc)) under normal FRs as per formula at Para 2.1(e) of this Office Order No. BSNL/26/SR/2002 dated 7.8.2002.

4. It is, therefore, requested that that all such cases of pay fixation may be reviewed and send a compliance report in this regard to this office.
