We would like to draw your kind attention to our letter cited under reference 3 above, wherein we had brought to your notice that in the Revised Pay fixation table with 78.2% IDA under Annexure of the letter cited under Reference 1 above, under Grade E3, the revised pay for Rs.14750 (with 78.2% IDA) has been shown as Rs.34170, which should have been Rs.34180 in accordance with the fixation method mentioned in letter cited under Reference 2 above.

It appears that the IDA @ 78.2% as on 1.1.2007 has been taken as 11534.50 without

rounding off to the nearest rupee.

We had requested you to kindly cause issue of necessary correction to the table in Reference 1 above and also issue of instructions to follow the corrected table when calculating revised pay fixation for pensioners with 78.2% fitment benefit. But no action has been taken for correcting the discrepancy till date.

We request you to kindly ensure that necessary correction to the table is issued without

further delay.
