R/Sir,

We would like to call your kind attention to BSNL letter cited above calling for applications from AGM/DE (T) working in various circles / projects /regions etc. for posting in BSNL Corporate Office on transfer basis.


2. We do not know as to what was the necessity to suddenly and so urgently call for volunteers from all over the country, when proposal to promote around 1300 TES Grp B officers to DE/ AGM adhoc is under active consideration of Management Committee of BSNL Board. After approval of the Management Committee of BSNL Board sufficient number of officers working in BSNL Corporate Office are likely to be promoted to STS on adhoc basis and can be posted in BSNL Corporate Office itself. Hence, there is no need to call volunteers for posting in BSNL Corporate Office from AGM/DE Grade Officers. Further, this will also result in very huge expenditure to BSNL by way of Transfer benefits both to the officers to be transferred now from various Circles/units to BSNL CO as well as the officers who on promotion will have to be transferred out of BSNL CO. This could be avoided by waiting for some more time to fill the AGM/DE vacancies in Corporate Office.

It is another fact that the **TES Group B officers in BSNL Corporate Office of 1981 recruitment** are not being given officiating promotion as DE/AGM, while even officers of 1994 and later years of recruitment are officiating as DEs/AGMs in other Circles/Units. If at all it is urgently required to fill the DE/AGM vacancies in Corporate Office, the same can be done by granting officiating promotion to the Group B officers in Corporate Office or by allowing looking after arrangements.

4. In view of the above, we would request you to withdraw BSNL letter under reference and take necessary action for approving the proposal and holding the DPC to promote 1300 TES Group 'B' officers to DE adhoc so that the requirement of additional DE/AGMs at BSNL Corporate Office is also met.
