Subject: **Relaxation in aggregate marks required in JAO Part II LDCE held in January 2010 –reg**

Sir,

We had earlier requested vide our letter No.AIBSNLOA/CHQ/2010/29 dated 26th May 2010 for relaxation in minimum qualifying marks in CPWD Paper of JAO Part II LDCE held in January 2010, since it was reported that a considerable number of candidates who had qualified in the other four Papers failed to make it in CPWD Paper only.

2. Now, it has come to our notice that though a large number of candidates had secured minimum qualifying marks in all the five papers, unfortunately they were unable to secure the required aggregate of 45% marks and therefore were declared unsuccessful. Some of them had scored just a few marks less than the aggregate. To cite a case, *Shri A.S.Sunil of Ernakulam, Kerala, has scored 238 out of 550 which aggregates to 43. Even worse is a case where Shri R.Dhanakodi of Karur, Tamilnadu has scored 247 out of 550 aggregating to 44.9% (just 0.1% short) having qualified in all the five papers and still has been declared unsuccessful.* [Copies of representations of these two candidates are enclosed]

3. Many more such cases are being reported and we believe that there are more such cases unreported. All the five papers in the examination were of descriptive type and hence variations in valuation by different evaluators are always possible, unlike in objective type questions. With so many vacancies remaining unfilled and this examination being the last chance for promotion to many aspiring candidates and also in consideration of acute shortage and

requirement in JAO cadre, relaxing the aggregate mark as well as the minimum qualifying mark in CPWD paper as per our earlier request will bring no harm to any one or the Company.

4. We therefore request that a sympathetic consideration be given to the issue and relaxation in minimum qualifying marks in CPWD Paper as well as in the aggregate marks be ordered and a revised list of successful candidates in all the Circles be notified.
