**Subject:-** Issue of promotion order from JTO(T) to SDE(T) non filling up SC/ST quota as per post bases roster system- case represented by Shri V P Arya, G 5, AIBSNLOA.

Reference No. 19-1/2010-SCT/119 dated 17.03.2010

The para wise information is as under:-

Para 182:- DPC for promotion of JTO(T) to SDE(T) grade for vacancy year 2006-07 and 2007-08, was held in March-April-2009 to fill 67% quota under Seniority cum fitness stream. Total vacancies were 2542. A Promotion list of 2041 JTOs was released on 15.5.2009 and later on lists of left over JTOs for promotion were also released on subsequent dates. The details are as under:-

Para 3 to 5:- The left over vacancies could not be filled up due to non availability of ACRs/VCs and for which this office is processing with the concerned circles. Recently a list of 128 such JTOs has been put on the net for submitting the required documents to take up the cases for promotion. It is also submitted that the eligibility list prepared for the promotion have not sufficient JTOs under OC and SC category. This is due to the fact that when the eligibility list was under preparation, then result of LDCE which was held on 15.7.2007 was declared and JTOs who have cleared the exam have got promotion through 25% quota and accordingly their names have been deleted from the eligibility list and hence the shortfall occurred. As preparation of eligibility list is a lengthy assignment, hence the process for promotion was initiated with the available eligibility list. In respect of shortfall in SC vacancies as mentioned in the letter, it is submitted that presently we are not having sufficient SC candidates in the eligibility list.



The process to prepare a new eligibility list is under progress and the left over vacancies in all the categories i.e. OC, SC and ST will be filled in one lot. Moreover the process to update the roster is also in progress and after its finalization, the vacancy position will be more clear and accurate, and only then the left over vacancies will be filled along with 2008-09 year vacancies.

It is pertinent to mention here that LDCE for the promotion to SDE(T) under 33% quota is scheduled on 4.7.2010 and the eligible SC candidates can compete in the said exam. The opportunity is very much open to the officers to get promotion to SDE(T) grade.

Accordingly, AIBSNLOA may be informed suitably
