Subject: Non- disbursement of salary and other dues to BSNL employees in time - regarding

Respected Sir,

We hereby convey our serious concern over non- disbursement of salary and other dues to BSNL employees in time. Salary of the employees has been delayed for the fourth month now in this year while contract labourers have not got salary from last six to eight months. It is frustrating that the employees who used to demand Bonus before Puja have now been left to plead for salary before Puja and Diwali. BSNL is continuously facing liquidity crisis for nearly a year now and still struggling to clear dues towards electricity bills, vendor bills, medical bills, contract labour wages and crediting of recovered GPF amount, loan instalments, insurance premium etc to the concerned authorities.

Talks of revival package for BSNL have been going on unendingly. Messages are being circulated in media and social media about Finance Ministry proposing closure of BSNL, creating panic among employees as well as the customers. We believe that immediate cash support from the Government / DoT is required to ensure that the situation does not go out of control.

Both the BSNL Management and the DoT have been keeping a studied silence during the entire period, smacking of complete insensitivity towards the employees' concern.

Therefore, we want an urgent meeting with you to have a knowledge of the measures being taken to come out of the crisis and for disbursement of September salary immediately so that we can apprise our members about the steps taken by the management for coming out from the current situation.

We once again request your good self to take necessary action for disbursement of salary and other dues immediately otherwise we will be left with no other alternate than to go on one day Hunger strike on 18.10.2019 in protest against the insensitivity.
