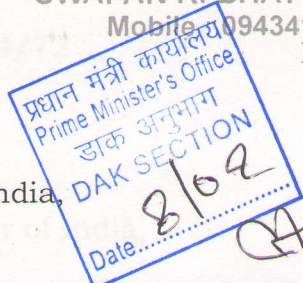

**Subject: Request for Constitution of Third Pay Revision Committee for Executives of Central Public Sector Enterprises – Elusive response by DPE – regarding**

Respected Sir,

We are very much grateful for immediate referring of our letters cited above by your office to the Department of Public Enterprises on the issue of pay revision of Executives of all Central Public Sector Enterprises, which will become due on 1.1.2017.

2. More than a year back, in response to our letter dated 8.9.2014 (copy Enclosed) and in deference to PMO reference dated 14.10.2014, the DPE had stated vide its letter dated 5.12.2014 (Copy Enclosed) that **“the process of constituting 3rd Pay Revision Committee has been initiated.”**

3. Now, in response to our letter dated 24.11.2015 (Copy Enclosed), which has been referred by PMO to DPE on 1.12.2015, the DPE has responded on 14.1.2016 (Copy Enclosed) stating that **“the constitution of Third Pay Revision Committee is under consideration.”**

4. We are very much concerned about the reply of the DPE in respect of an issue referred to by PMO, since it is very elusive and does not precisely state when the committee will be constituted although it had said more than a year back that “the process of constituting 3rd Pay Revision Committee has been initiated.”

5. We therefore request you to kindly advise the DPE to constitute the Pay revision committee without further delay, since delay in constitution of the committee, later taking decision on pay revision and subsequent orders after 1.1.2017 will result in avoidable anomalies, as has been the experience in the past.
